registered representatives. In this list, the advisors were ranked by assets under management using the Discovery-RR database system. Discovery maintains data on the registered rep universe then validates the ranking via direct survey. Some advisors from past years are not on this year's list.

The awards, in four categories, were presented by the Invest in Others Charitable Foundation and InvestmentNews.

Robert Wolford, managing director at Hollencrest Capital Management of Newport Beach, Calif. was named Volunteer of the Year.

Mr. Wolford is chairman of Operation Homefront, a national non-profit that assists active-duty military families.

Brett Ellen, president of American Financial Network of Calabasas, Calif., was awarded the Mentoring Excellence Award for helping children in Calabasas form their own non-profit community organization, Turn Kindness On Helping Hands.

The Community Service Award was given to Robert Wamhoff, president of Wamhoff Financial Planning and Accounting Services Inc. of Hazelwood, Mo.

Mr. Wamhoff's charity, Just Because We Care, provides assistance to an impoverished village in Honduras.
